**Footnotes**

AMY'S BUDDHA vied for the lead three wide, inched to the fore leaving the turn, bumped with P. BASS with a furlong to run, drifted in through the drive and gradually edged clear. P. BASS disputed the pace along the inside, was headed leaving the bend, drifted out under left handed urging and bumped with AMY'S BUDDHA near the furlong marker, was unable to match strides with that one but continued on willingly to hold the place. CHEROKEE FLARE settled saving ground, got through to make a steady advance and was along in time to earn the show. TAWFEER settled racing in hand along the inside, angled out leaving the turn to make a mild bid but lacked the needed late response. CUNNINGHAM was hustled along between horses then three wide, was carried out further entering the stretch, but lacked a response when called upon. CITYSTEPPER chased the dueling leaders three wide, but faltered from between horses on the turn and faded. TRIPPIN SWEET was hustled along four wide in the second flight but was never a factor. FIELD COMMANDER was through early. The trainer and jockey of P. BASS lodged an objection against AMY'S BUDDHA for alleged interference in mid stretch, but following the review the Stewards made no change to the order of finish.
