ON MY WAY reserved early, advanced off the rail on the second turn, angled out for the drive. RAILLERY vied for the lead along the inside and held on gamely but was outfinished. PLEASANT COMMENT forwardly placed, challenged three wide on the second turn, gained a short lead with a furlong to go and held on gamely. DESTINY'S REWARD reserved early, saved ground with three furlongs to go, angled out a bit for the drive and made a late gain. SMARTY SLEWY forwardly placed near the rail, waited briefly late on the second turn then made a late gain. KENTUCKY GAL outrun early, saved ground on the second turn and was no real threat. CATAWBA DEE could not menace. MS. TURDUCKEN outrun for a half, was no factor. BIANCA QUEEN

alternated for the lead off the inside and tired. HERO'S DREAM within striking distance, raced four wide approaching the stretch and gave way. DUE TO RHUMBA five wide with a quarter mile to go, was no factor. LADYS GOT SOUL forwardly placed early, faded.
