SO ENTICING gained the lead at the start, moved inside, drew off into the upper stretch and concluded under solid hand urging. ENQUIRY WOMAN, well placed while stalking the pace four or five wide, couldn't threaten SO ENTICING in the drive while clearly second best. GOLDEN ENCOUNTER, outsprinted early, improved position outside while no threat to the top two. THUNDER SANDS bobbed at the start, moved out four wide to chase the winner, held on well into the stretch and weakened. EXOTIC ANGEL, nicely placed inside to the stretch, swung out for the drive but flattened out. SUZANNE'S FLYING, three or four wide throughout, wasn't a factor.
