PROVE YOURSELF stalked the pace off of the inside, angled in leaving the second turn, got through and wore down TIMBUCTO through the final furlong. MAX SILVERHAMMER was unhurried into stride, tucked in to save ground, responded when roused with three furlongs to run, circled five wide to make his bid, finished well but was unable to reach the winner. TIMBUCTO opened clear to dictate terms off of the inside, was collared between horses with a furlong to run and grudgingly gave way. FALLING KNIFE was allowed to settle, angled out entering the stretch, six wide, but found his best stride too late. SLICK PARDONED ME settled in hand, advanced between horses through the second turn toward the inside, lacked room entering the stretch, altered course off of the rail but went evenly thereafter. AU MOON tracked the pace three wide, moved with the winner through the second turn, but weakened between horses during the drive and gave way. VOW TO WAGER showed little in a dull effort. KIND REGARDS was through after a half.
