**Footnotes**

SHIMMERING FOREST stalked the pace two wide, forged command with a furlong to run, drifted in through the drive and gradually edged clear. CODOY settled saving ground, ranged into striking distance through the second turn, got through entering the stretch, was caught in tight late, steadied slightly, came again and was up in time to earn the place. MICKEJOE was forwardly placed between horses, weakened slightly following a prolonged drive but had enough left to hold the show. HONEST ED set the pressured pace along the inside, was collared with a furlong to run and weakened during the drive. CONSULATE settled in hand, bid between horses entering the stretch, was caught in tight late and finished evenly. ONELIFEISNOTENOUGH chased the pace three wide, but faltered during the drive and gave way. SOUTHERN CAUSEWAY failed to respond. POPLAR HOUSE showed little. BRIGHT PRINCE was never a factor. RUSTICITY was through after a half. The Jockey of HONEST ED lodged an objection against SHIMMERING FOREST for alleged interference in the drive, but following the review the Stewards made no change to the order of finish.
