### Footnotes

SOCKAROOI stalked the pace three wide, came four wide to make his bid, and was fully extended to wear down RIVENDELL and prevail by the narrowest margin. RIVENDELL pressed the pace two wide, took over after a half, fought on gamely through a long drive but was turned away in the shadow of the wire. CHALICE attended the pace along the inside, shifted out to make his bid between horses entering the stretch, shied from the whip of the jockey of SOCKAROOI near the furlong marker, kept on with dogged determination but wasn't quite good enough. DREAMS CUT SHORT settled in hand, advanced between horses through the second turn, angled out entering the stretch but failed to sustain the drive. ENCYCLICAL made a middle move five wide, offered a mild bid but failed to sustain the drive. GITTO was unhurried into stride, settled well back, finished with a belated gain but failed to threaten. ALFRIE'S FRIENDS failed to respond. ABENDLIED pulled to the lead to set the pace, disputed the issue to the second turn and stopped. The Stewards conducted an inquiry into the stretch run of CHALICE and SOCKAROOI, but following the review deemed there to be insufficient video evidence to warrant a change to the order of finish.
