APPEALING RESUME was bumped at the start, pressed the pace from between foes, angled out nearing the quarter, reached the leaders with a furlong to run and edged clear. PISTOLPACKIN'GAL was bumped at the start, showed no early speed, angled out in mid-stretch and finished with good energy. ALFAWNSOUL was off a step slow, rushed to contention, was bumped nearing the three-sixteenths pole and finished with good courage. PRINCESS DELANEY was never far back while racing along the inside and lacked the needed late closing response. SPEAK FRANKLY went to the front at once, opened a clear lead before going a quarter, raced off the rail into the stretch, bumped with ALFAWNSOUL nearing the three-sixteenths pole and gave way through the final furlong.
