EXCLUSIVE DIVA sprinted clear at once, saved ground while setting the pace, responded when set down for the drive and drew off to win with complete authority. ROYAL MOSES was taken back soon after the start, saved ground through the turn, angled out nearing the quarter and again at the three-sixteenths pole and finished with good energy to gain the place. LADY HOKULEA hesitated at the start, rushed to contend, chased the winner from the outside, was no match for that rival in the drive and lost the runner-up award late. MUCHAS CORONAS raced off the pacesetters early, moved between rivals nearing the quarter, angled out into the lane and finished evenly. TALK TO MY LAWYER broke sharply to chase the leaders from the outside and gave way after going a half. SWEET SAGA lacked early speed, moved up from the far outside for a contending position nearing the quarter and failed to gain in the drive. RELIABLE EMA chased the leaders from the inside and weakened after going a half. MATTIE BLUE was void of early foot, raced far wide through the turn and was not a threat.
