**Footnotes**

BIRDIE GIRL was away in good order to press the pace of MILE EASY from the outside, moved up to take command nearing the five-sixteenths pole, quickly opened a clear margin and held SWEET PLEASURE at bay in the drive. SWEET PLEASURE chased the winner from the outside throughout, could not gain on that rival in the drive but was clearly second best. CAT VON DIVA lacked early speed, raced wide through the turn and finished with a steady bid. DUCOTI hesitated at the break, raced wide through the turn, angled out further into the stretch and finished with good energy. SCENT OF CHRISM was void of early foot, saved ground through the turn, angled out and back inside in mid-stretch and finished with a belated bid. A COURTING VENTURE raced off the pacesetters early, moved far outside through the turn and failed to rally. TULLAMORE DEW chased the leaders from the outside for a half and gradually weakened. MILE EASY was away alertly to set a pressured pace from the inside and weakened after going three furlongs.
