BOGUS PLAN broke sharply, settled racing in hand, responded when roused nearing the five-sixteenths pole, came three wide into the lane, wore down her rivals inside the furlong marker, and edged clear in the final yards. PREMO COPY stalked the dueling leaders racing removed from the rail, made a bold bid leaving the turn, opened a clear lead entering the lane, but was unable to resist the winner late. ACURE FOR GERI was unhurried early, closed the gap through the bend along the inside, angled out during the drive and was along for the show. PERFECT PLAN pressed the pace racing along the outside of STELLA BE GOOD, bested that one leaving the turn, but failed to sustain the drive. STELLA BE GOOD set the pressured pace racing along the inside, was headed leaving the quarter pole and gave way readily thereafter. WINNING APPROACH failed to respond.
