GIL was bumped at the start, raced just off the leaders from the outside, moved up to take a slight edge with a furlong to run, bumped with TOP TOP late and prevailed over that rival by a narrow margin. TOP TOP pressed the pace from the inside, dropped back nearing the quarter, came back to engage the winner in the inside the furlong marker, bumped with that foe late and just missed. TOP DEFENSE was bumped at the start, showed no early speed, saved ground throughout and finished with good energy. HIJO DEL SOL chased the leaders from the outside, moved up to offer a bid into the lane and gave way in the drive. ISEEISAYYOU PAY raced off the leaders early, moved outside through the turn, angled further out nearing the three-sixteenths pole and did not threaten. SPICY FORMULA broke in, lacked early speed, raced wide through the turn and did not reach contention. BOISE CREEK was away alertly to set a pressured pace from off the rail and weakened after going a half. The Stewards conducted an inquiry concerning the bumping between GIL and TOP TOP nearing the wire and after reviewing the films concluded it was mutual exchanges and made no change.
