DEMON WARLOCK stalked the pace racing two wide, angled out to launch his bid leaving the second turn, drew even leaving the second turn, brushed repeatedly with POKER BRAD through the drive, and was fully extended to narrowly prevail. POKER BRAD pulled to contention racing three wide, forged a narrow lead nearing the quarter pole, brushed with DEMON WARLOCK through the lane, and grudgingly gave way in the final strides. BRIARTIC GOLD stalked the pace racing along the inside, made a mild bid racing two wide, lacked the needed late response, then was all out to just hold the show. EZRA settled racing in hand, made a steady advance racing five wide, but failed to seriously threaten. WILLIE THE CAT set the pressured pace racing along the inside, was headed nearing the quarter pole, and gave way readily thereafter. ALFURUNE saved ground to little avail. SLEWICIDE CRUISE was hustled along racing four wide throughout and failed to respond. BUB settled in the second flight and was never a factor. The jockey of POKER BRAD lodged an objection against DEMON WARLOCK for alleged interference through the stretch, but following the review the Stewards found insufficient contact to warrant a change to the order of finish.
