COURTING SEATTLE dueled for the lead from between foes, opened a clear lead into the lane and held sway to the wire. CALL COLUMBO was away alertly to duel for the lead from the outside, could not match strides with the winner in the drive but finished well to save the place. SNARK showed no early speed, moved between foes nearing the three-sixteenths pole and finished evenly late. D DEVIL pressed the pace from the outside and gave way in the drive. BLACKJACK KETCHUM lacked early speed, saved ground through the turn, angled out sharply nearing the quarter and did not reach contention.
