GENTLEMAN LAWYER stalked the leaders from the outside, moved up to take command nearing the eleven-sixteenths pole, turned back the bid of BIJOU BARRISTER nearing the five-sixteenths marker and edged clear late. BIJOU BARRISTER was away alertly to chase the leaders from the outside, moved up to offer a bid nearing the five-sixteenths pole, could not match strides with the winner in the drive but finished well to save the place. MEDICINE CREEK lacked early speed, saved ground through the turns, angled out in mid-stretch, steadied when BIJOU BARRISTER came in slightly and finished with good energy when clear. WHITNEY BRIDGE went to the front soon after the start, opened a clear lead before going a quarter, dropped back for a stalking position, angled out nearing the quarter and finished with good courage. WAY TOO MUCH raced off the leaders from the outside throughout and did not menace.
