EXCLUSIVE DIVA duelled for the lead from the inside with HARDBODY, disposed of that rival with a furlong to run and drew off. TALK TO MY LAWYER hopped at the start, raced wide through the turn, moved up for a striking position in mid-stretch but failed to gain on the winner late. HARDBODY broke sharply to duel for the lead from the outside and gave way to the winner after going a half. SEMELE raced off the leaders from the inside throughout and finished evenly in the drive. GENTLEMAN'S RED raced off the pacesetters from the outside throughout and failed to rally. SHE'S TOPS lagged early, raced far wide through the turn and was not a factor. SEA SPLENDOR showed brief speed from the inside and weakened.
