**Footnotes**

JUDICATURE stalked the leaders from the outside, moved up to take command with a quarter to run and quickly drew off. JACOLATT lacked early speed, moved between foes into the lane and finished with good energy. WELKEN was void of early speed, checked and altered course nearing the three-sixteenths marker and was full of run when clear. MARIANNE ROSE was hustled along to set a pressured pace soon after the start, opened a clear lead with five-sixteenths to run and gave way in the drive. SKEWING was never far back while racing along the inside and lacked the needed closing response. ASURASLEW was away alertly then dropped back behind the pacesetters, raced wide through the turn and failed to threaten. MS. PATRONA broke sharply to press the pace from the outside and weakened after a half. CITY COLORS raced just off the pacesetters, drifted out into the stretch and failed to menace. CASCADE ROSE lacked early speed, raced wide through the turn and was not a factor. CATSILVERANDGREY raced off the rail throughout and failed to rally.
