FOR TWO-YEAR-OLD FILLIES, PROGENY OF STALLIONS STANDING IN 2007 THAT HAVE BEEN DULY NOMINATED.

Stallions to nominated at a fee of \$500 or 50% of published stud fee by April 15, 2007. \$125 to enter, \$125 additional to start. 5% of gross NWRS monies shall be paid to the eligible nominators of the top 5 finishers. 5% of gross NWRS monies shall be paid to the eligible nominators of the of the sires of the top 3 finishers. Remaining monies to be divided 55% to the winner, 20% to second, 15% to third, 7.5% to fourth and 2.5% to fifth. Weights 119 lbs.; Maidens allowed 2 lbs. In the event more than 12 entries are received, preference in the draw for post positions will be based on money earned. Starters to be named through the entry box by the closing time of entries. The conditions of this race may be changed with the consent of the Washington Thoroughbred Breeders and Owners Association. STALLION NOMINATIONS CLOSED. Supplementary nominations may be made at entry time at a cost of \$1,500 (Stallion must be eligible).

CARRABELLE HARBOR dueled for the lead from the outside, vied with IFORGOTTOBEME into deep stretch and drew clear of that rival though the final yards. IFORGOTTOBEME was bumped at the start, dueled for the lead from between foes, stayed on in the drive but could not match strides with the winner late. BELL ADIEU lacked early speed, raced off the rail through the turn, angled out into the stretch and finished with a steady rally. THE GANG AND I was bumped at the start, dueled for the lead from the inside and gave way after going a half. ALLISON RIDGE was bumped at the start, raced off the leaders from the inside, angled out nearing the quarter and did not offer a bid. FOR THE REST OF US lacked early speed, raced wide through the turn and did not threaten. JULIE M C M broke in, showed no early speed, raced far wide through the turn and was not a factor.
