### Footnotes

PASTA TIME was allowed to settle early, moved up from the outside to offer a bid nearing the five-sixteenths pole, vied with SARGANIS through a prolonged drive and proved best. SARGANIS was never far back, moved up to engage the leaders nearing the five-sixteenths marker, dueled with the winner through the final quarter and grudgingly gave way to that rival. TURNTABLE BAY was away alertly to set a pressured pace, opened a clear margin nearing the nine-sixteenths pole and gave way after going three-quarters. STORMIN' PATRICK was fractious at the gate, broke in the air, veered inward, lagged early, raced far wide through the second turn and did not reach contention. REASON TO RECKON broke sharply to press the pace from the inside and gradually weakened after going a half. ARMED SERVICE stumbled at the start and unseated his rider.
