FOR THREE-YEAR-OLDS AND UPWARD. By Subscription of \$100 each, which shall accompany the nomination, \$400 to enter, \$400 additional to start with \$50,000 guaranteed an additional \$50,000 from the Breeders' Cup Fund for cup nominees only. The host association's guaranteed monies to be divided 55% to the owner of the winner, 20% to second, 15% to third, 7.5% to fourth and 2.5% to fifth. Breeders' Cup Fund monies also correspondingly divided provided a Breeders' Cup nominee has finished in an awarded position. Any Breeders' Cup Fund monies not awarded will revert back to the fund. Field size will be limited to 12 starters. High weights preferred. In the event field is oversubscribed and two or more horses are drawing for post positions within the gate; preference is given to Breeders' Cup nominees only of equal racing quality or weight assignments ( respective of sex and weight for age). Starters to be named through the entry box by the closing time of entries. Breeders' Cup, Ltd. will award a trophy to the winning owner. Nominations closed at 1:00PM Saturday, July 23, 2005 with 9.

FLAMETHROWINTEXAN sped clear to dictate terms racing off the rail, repelled the challenge of POKER BRAD leaving the second turn, and gamely led throughout. POKER BRAD attended the pace racing three wide, offered his bid leaving the second turn, was no match for the winner, then was all out to hold the place. R. ASSOCIATE settled saving ground, got through to make a steady advance, drifted out into the stretch bumping GRAFTON SQUARE, was straightened away and was fully extended to earn the show. GRAFTON SQUARE settled racing in hand, came three wide to make his bid, was bumped inside the furlong marker, continued on willingly and was gaining slightly. MR. MAKAH was unhurried early, came five wide to make a belated rally, but failed to threaten. MY CREED was hustled along racing four wide in mid pack, but came up empty leaving the second turn and faded. The Stewards conducted an inquiry into the bumping incident between GRAFTON SQUARE and R. ASSOCIATE and determined the contact to be mutual and made no change to the order of finish.
