Footnotes

PRINCESS DELANEY raced off the leaders from between foes, responded to steady urging and proved best late. BELLA CAVALLA lacked early speed, raced wide through the turn, angled further out in mid-stretch and finished full of run. BORTE was never far back while racing along the inside, angled outside nearing the quarter and finished willingly. HAVE'N A WILD TIME raced off the leaders early, checked nearing the three-sixteenths pole and finished with good courage when straightened away. SENORITA DE ORO lacked early speed, raced wide through the turn and did not threaten. ONO ANNIE was away alertly to chase the leaders from the outside, moved up to gain command nearing the quarter, gained a clear lead and gave way in the drive. NIFTYS CRYSTAL raced off the leaders early, moved outside through the turn and did not menace. GABBY AMERICAN was away alertly to open a clear lead before going a quarter, saved ground while setting the pace and weakened after going a half. STORM THE COURT hesitated at the break, raced off the rail throughout and was not a factor.
