### Footnotes

HETTY was away alertly to press the leaders from the far outside, moved up to engage MS. SUTHERLAND nearing the quarter, opened a clear lead with a furlong to run and held LIBERTY LAKE at bay to the wire. LIBERTY LAKE was never far back while racing from between rivals, moved inside into the stretch, reached a striking position inside the furlong marker but could not gain on the winner late. MS. SUTHERLAND broke sharply to duel for the early advantage from the outside and gave way to the winner after going five furlongs. SHE'S PURDEE was bumped at the break, lacked early speed, raced wide through the turn, angled out further nearing the three-sixteenths pole and did not threaten. LADY ROSBERG raced off the pacesetters from the inside, angled out into the stretch and was not a factor. DINER'S DIVA was never far back, raced wide through the turn and gradually weakened. BENATAR was bumped at the start, showed no early speed, raced wide through the turn and did not menace. YOU SEND ME was bumped at the start, disputed the pace from the inside for a half and weakened. I AM REVENGE was bumped at the break, lacked early foot, raced off the rail and did not reach contention.
