ROYAL MOSES was never far back, raced wide through the turn, moved up to engage the winner nearing the quarter but could not gain on that foe in the drive. TALK TO MY LAWYER chased the leaders from between foes, could not gain on the top pair in the drive but finished with good energy. MUCHAS CORONAS broke out, pressed the pace from the inside and gradually gave way. MISS TOP NITE showed no early speed, raced far wide through the turn and failed to threaten. LADY DAKOTA was away alertly to duel for the lead from the outside and gave way after going a half.
