COMPTON stalked the pace of MAZEL POWER throughout, responded to steady urging and wore down that rival in the final strides. MAZEL POWER broke sharply to open a clear lead before going a quarter, saved ground while setting the pace, increased his margin into the lane but could not hold off the winner late. D DEVIL was never far back while racing from between foes, could not gain on the leaders in the drive but finished with good courage. FORT YATES was bumped at the start, lacked early speed, raced off the rail into the stretch and showed some late run. OGIEOGILTHORPE was bumped at the start, raced wide through the turn and finished evenly in the drive. FIERCE CAT showed no early speed, raced wide through the turn and failed to threaten. CALL COLUMBO was away alertly to chase the leaders from the inside and gave way after the opening quarter. COURTING SEATTLE raced off the leaders from the inside, moved up for a contending position into the stretch and gave way.
