Footnotes

UGOTTHEMONEYHONEY broke out, raced just off the leaders early, moved outside through the turn, reached the fore with a sixteenth to run and quickly drew clear. DEVILS DRAGONFLY was never far back, raced far wide through the turn and finished with a late rally. SONG OF SEATTLE dueled for the lead from the outside, gave way into the lane and came back late for the show. WIND A FLYIN broke sharply to duel for the lead from the inside, opened a clear margin with a furlong to run, gave way nearing the sixteenth pole while drifting inward and continued to retreat. A COURTING VENTURE showed no early speed, saved ground into the stretch, steadied when WIND A FLYIN drifted inward at the sixteenth pole and lost all chance. FOREST BUNNY chased the leaders from the outside and weakened after the opening quarter. The stewards conducted an inquiry concerning the steadying of A COURTING VENTURE at the sixteenth pole and after reviewing the films concluded WIND A FLYIN had caused the incident and was disqualified from fourth and placed fifth.
