**Footnotes**

TEMPLETON lacked early speed, saved ground into the lane, angled out nearing the three-sixteenths marker and was up in the final jump to prevail narrowly. PERKY MOMENTS dueled for the lead from off the rail, opened a clear lead with a sixteenth to run and just missed in a game effort. RHYTHM TO RUN broke sharply to duel for the lead from the outside and gave way in the final sixteenth. TOP THREAT was bumped at the start, showed no early speed, was carried out nearing the quarter and finished with good energy. ANAWKSUNAMIN raced just off the pacesetters from between foes, drifted out slightly nearing the sixteenth pole and finished evenly. SKIPPYJON JONES raced wide through the turn and failed to rally. CONFIDENT SLEW was away alertly to chase the leaders from off the rail and gave way after a half. SHARPER EAGLE was bumped at the start, lacked early speed, steadied nearing the eighth pole, altered course to the inside, steadied again when ANAEKSUNAMIN came out and dropped back. The Stewards conducted an inquiry concerning the steadying of SHARPER EAGLE at the sixteenth pole and after reviewing the films concluded that ANAWKSUNAMIN had caused the incident by drifting out into SHARPER EAGLE and disqualified ANAWKSUNAMIN from fifth and placed him last.
