### Footnotes

CHAMPAGNEANDCAVIAR broke sharply to stalk the winner from the inside, moved up to engage that rival in mid-stretch, vied through the final furlong and edged ahead in the final yards. EXCLUSIVE DIVA was away alertly to set a pressured pace from just off the rail, responded when challenged by the winner nearing the eighth pole and just missed through a stiff drive. OUR ELEANOR was never far back, raced wide through the second turn, reached a striking position into the lane but lacked the needed closing response. ROYAL MOSES raced off the pacesetters from the inside, dropped back nearing the five-eighths marker, moved far outside through the second turn and finished with good late speed. WHISKEY MINER raced just off the leaders throughout, reached a contending position approaching the stretch but failed to gain in the drive. TALK TO MY LAWYER pressed the pace from the outside for six furlongs and weakened. STEPHIANO showed no early speed, raced off the rail into the lane was not a factor. REGAL BETTY lacked early foot, saved ground throughout and did not reach contention.
