Footnotes

TOUCHABULL stalked the early pace from three deep, came three wide into the stretch to challenge for the lead and narrowly prevailed. PIC EM HOF dueled for the early lead from three wide, continued on gamely to the finish and just failed. SIN CITY SLEW tracked the leaders from five wide, moved up to challenge for the lead from four wide in the upper stretch but was not good enough in the final furlong and had to settle for a minor award. ONE FOR YOU dueled for the lead from two wide and tired in the stretch. KNIGHT OF CUPS allowed to settle early, advanced into a striking position from between horses on the bend but gave way in the stretch. SASSY LITTLE SARAH close up early from the inside, dropped back slightly on the turn, waited behind the top flight until mid-stretch, tried to force her way through a small hole but clipped heels and lost the rider. The Stewards conducted an inquiry into the incident and after viewing the video tape ruled no change.
