### Footnotes

SO WHATABOUT broke sharply then was reserved off the pacesetters from the outside, moved up to offer a bid nearing the quarter and drew clear through the final yards. DEVILISH FACT was away alertly to duel for the lead from between foes and gave way grudgingly in the drive. TARAGE lacked early speed, raced off the rail into the lane, angled outside in mid-stretch and finished with good energy. COURTING SEATTLE was never far back, raced wide through the turn and lacked the needed late response. ETERNAL WIND showed no early speed, raced wide through the turn and found his best stride late. BOX TOP was void of early speed, raced wide through the turn and did not reach contention. MIGHTY ALL STAR dueled for the lead from the outside and weakened after going a half. PIRACY showed no early speed, saved ground throughout and failed to rally.
