WELL MAM allowed to settle early, raced in the clear down the backstretch, angled to the inside to save ground going into the second bend, angled out to the three path near the quarter pole to launch her bid and wore down his rivals in the final sixteenth. MARQUETRYINMOTION pressed the early pace, forged to a short lead in mid-stretch, continued on gamely to the wire but was unable to resist the winner. MAID IN MONROE set the pressured early pace and gave way grudgingly in the final furlong. TRIAL BY JUDGE allowed to settle into stride, was four wide on the second turn, made a belated rally but had too much to do. ECHO WEAVER unhurried early, failed to threaten the top flight. ANDORAS ATTITUDE void of early speed, was five wide at the quarter pole and failed to menace. BOBBIE WAGNER pressed the early pace while racing three wide, started to drop back on the second turn and faltered. PUNXSUTAWNEY stalked the pace for the first half-mile and stopped.
