### Footnotes

ONE QUICK BREW pressed the pace from the outside, moved up to engage FOLLOWS NONE nearing the five-sixteenths marker, came in to brush that rival in the drive and proved best late. FOLLOWS NONE broke sharply to set a pressured pace, responded when challenged by the winner nearing the five-sixteenths pole, was brushed by that rival through the lane and could not match strides through the final yards. ICY RIDGE (IRE) raced off the leaders early, angled out into the stretch and finished with a solid rally. MR. MAKAH showed no early speed, raced off the rail through the turn, steadied nearing the three-sixteenths pole and finished with good late energy. PLATINUM KATILLAC raced off the leaders from the inside throughout and failed to rally. COURTING SEATTLE chased the leaders from the inside, angled out in mid-stretch and gave way. HICKORY ROAD lacked early speed, raced wide through the second turn and did not threaten. The rider of FOLLOWS NONE lodged an objection against ONE QUICK BREW concerning the brushing through the lane and after reviewing the films the Stewards made no change. The rider of MR. MAKAH lodged an objection against ICY RIDGE concerning the steadying of his mount when that rival came out at the three-sixteenths pole and after reviewing the films the Stewards made no change.
