SNAKE ATTACK was away alertly to duel for the lead from the outside, opened a clear lead nearing the three-sixteenths pole and drew off through the lane. ZAGREUS was bumped at the start, lacked early speed, saved ground into the stretch and finished with good energy. ROOSTER CITY raced off the leaders early, moved outside through the turn and finished evenly. WINNING MACHINE chased the leaders from the outside and gave way in the drive. FANTASYVILLE showed no early speed, raced off the rail throughout and did not menace. EX TREMELY COOL was never far back while racing from off the rail and did not threaten. GREAT APPEAL dueled for the lead from the inside and weakened after the opening quarter.
