FOR TWO-YEAR-OLD FILLIES. \$350 to enter, \$350 additional to start. 5% of gross NWRS monies shall be paid to the eligible nominators of the top 5 finishers. 5% of gross NWRS monies shall be paid to the eligible nominators of the sires of the top 3 finishers. Remaining monies to be divided 55% to the winner, 20% to second, 15% to third, 7.5% to fourth and 2.5% to fifth. Weights 119 lbs. Non-winners of a stakes allowed 2 lbs.; Non-winners of \$7,500 twice allowed 4 lbs.; Non-winners of one such race allowed 6 lbs. In the event more than 12 entries are received, preference in the draw for post position will be based on money earned. Starters to be named through the entry box by the closing time of entries. The conditions of this race may be changed with the consent of the Washington Thoroughbred Breeders and Owners Association. See breakdown of Northwest Race Series on page 40. Limited to 10 starters. NOMINATIONS CLOSED. Supplementary nominations may be made at entry time at a cost of \$5,000.

**Footnotes**

BLUEBERRY SMOOTHIE was bumped at the start, set a pressured pace from off the rail, opened a clear margin approaching the stretch and drew off through the lane as a handy winner. INNOCENT LOVE pressed the pace of the winner from the outside throughout, was no match for the winner in the drive but held on well to retain the place. MADAME PELE showed no early speed, raced far wide through the turn, moved up for a contending position into the stretch but failed to gain the drive. AGOODLAWYER WILLDO was bumped at the start, pressed the pace from between foes and gradually weakened. SONG OF SEATTLE was bumped at the start, hard to rate, moved up from the inside to offer a bid nearing the half mile marker and weakened soon after.
