**Footnotes**

BEST PRACTICES was away alertly to set a pressured pace, turned back the bid FOUNTAIN RIDGE with a quarter to run and held that rival at bay through the lane. FOUNTAIN RIDGE pressed the pace from the outside, engaged the winner into the lane but could not get by that rival in the drive. LOVE A BULL raced just off the leaders from the inside and finished willingly. JAZZIN WITH JAZZY stalked the leaders from the outside and gradually gave way. COUNTRY MOONBEAM lacked early speed, raced between rivals into the stretch and finished evenly. WINNING WEAVE was void of early speed, raced wide into the lane and failed to menace. TRIAL BY JUDGE was never far back, raced wide into the stretch and weakened. DBLE DIAMOND NORMA showed no early speed, raced wide through the turn and was not a factor.
