TALK TO MY LAWYER broke awkwardly, quickly opened a clear lead, saved ground while setting the pace, dropped back nearing the five-sixteenths pole, angled outside, re-bid, bumped with HAVANNA RED through the final yards and proved best over that rival. HAVANNA RED chased the leaders from the inside throughout, moved up to take a slight edge in mid-stretch, bumped with the winner late and grudgingly gave way to that rival. LEADERSHIP lacked early speed, raced far wide through the second turn and finished with some late run. SWEET SAGA was never far back, moved up from between rivals to offer a bid nearing the half, gained a slight edge and weakened in the drive. CHU AND I pressed the pace from the outside, dropped back nearing the half, re-bid nearing the quarter and also weakened in the drive.
