### Footnotes

FLAMING BULLET was unhurried early, raced off the rail through the turn, angled outside into the stretch, responded to steady urging and caught LONDON EXPRESS in the final strides. LONDON EXPRESS raced off the leaders early, angled outside nearing the quarter, moved up to offer a bid with a furlong to run, gained a slight edge but could not resist the winner in the final yards. SKYRIDER was never far back while racing along the inside, moved up to engage HIRED HAND nearing the three-eighths marker and gave way in the drive. HIRED HAND was away alertly to set a pressured pace from the inside and gave way after six furlongs. PIRATES DEPUTY lacked early speed, saved ground throughout and failed to rally. BUCKSHOT WEST broke sharply to press the pace from the outside and weakened after going six furlongs. TRACFURTOGAFUR showed brief speed, weakened and was vanned off after pulling up.
