GHOSTBUSTIN' made a steady advance, was all out at the finish. EVIL GENIUS raced in close to the leader, lugged out in the mid stretch and checked. I'MABADBOY made a steady advance and was up for show. BOB'S WILDCAT BOY set the pace through the half pole and faded in the early stretch. BLUE TWISTER made a steady advance, offered his best foot too late. BROKE PERIOD showed brief speed, dropped back at the half pole. BURN RATE was void of early speed, offered his best foot too late. SMART TRIBUTE raced even throughout, was no threat. MR. JOHN JOHN failed to menace. EXPANSIONIST gave a dull effort. ALLY'S WISE MAN was in contention at the quarter pole and then steadily retreated. MEETMEATTHEBANK was outrun. MR. JOHN K. was no factor. ANTE UP THE LAKE raced up close, weakened in the the turn. THERE WAS A JOCKEY'S OBJECTION #13-EVIL GENIUS AGAINST #14-GHOSTBUSTIN' FOR ALLEGED INTERFERENCE IN THE STRETCH THE CLAIM WAS DISSALLOWED.
