RUSTON RED stalked the early pacesetter, advanced position and edged up to the lead, raced four wide in the turn, began to duel with LIFEFOOTSUE into the stretch, shook free and drew clear in the late drive. MISS MACABE saved ground along the inside, began to advance position heading into the turn, remained near the rail in the stretch and was up in time for place. DAMA DECOLORES was unhurried early and settled in behind the early front runners, made a bid heading into the turn, raced four wide and raced along for show. LITEFOOTSUE took command by a slight margin, felt pressure from RUSTON RED heading into the turn, they began to match strides into the stretch, continued bid but could not keep up the pace in the late drive. ALANA BUTANA stalked the early front runners, made a bid and slightly improved position, raced five wide in the turn and came up empty in the drive. GLEE ALEE showed

early speed while racing near the inside and steadily weakened. SINGLE LADY raced near the back of rivals early, made a bid in the stretch, raced three wide and was not enough to make a impact late. CHOOSE THE CASH raced near the inside and failed to be a factor. WHISPER TO JACKSON made a brief bid between rivals in the early going and had nothing left late. BRAX LEE'S LIL SIS made a brief bid and steadily faded. ALL MOST ENOUGH lacked response throughout. TAYLORS PATRIOT eased to wire.
