GOLDEN RAIL out sprinted early, moved off the inside, loomed outside MS FREDDIE BRIGHT entering the drive, gained the edge and proved best under a drive. MS FREDDIE BRIGHT showed speed from the rail, shook clear before the turn, responded when collared but was no match late. FANCY DEALER forwardly placed off the rail, angled in entering the turn, advanced but had no final kick. VICKI DARLING unhurried, could make little impact. ZULU LULU back early, swung out for the drive and then improved position. POP'S ANGEL trailed until the drive and showed late interest. MISS SLEW was outrun. ILE DE LINDA raced wide and was no threat. LADY LESLIE showed speed to the turn and then stopped. COLERO WILDFIRE was always outrun. SHE'SONTHEMOVE tired. BEVERLY KAY out sprinted early, faded.
