ORDINARY TIME unhurried in the early going, began a steady gain after a half, moved inside, rail bid just inside the furlong grounds, quickly clear. ST. ARIAN set the pace while out in the course, continued well off the rail into the lane when clear, came in a bit to bother WILDCAT LOVE, no match for the winner, narrowly held the place. A CLAIM OF FOUL BY THE RIDER OF WILDCAT LOVE AGAINST THE RUNNER UP FOR ALLEGED INTERFERENCE IN UPPER STRAIGHT WAS NOT ALLOWED. POWERED BY STEWIE void of early speed, rallied through traffic, getting to the runner up. HIGH HOPES E DAY off slowly, raced well back for six furlongs, came four wide into the lane, lugged in midstretch when advancing, steered out and finished up evenly. WILDCAT LOVE broke on top, chased the runner up, was beginning to tire when bothered by that foe upper stretch, continued to back up. LOUISIANA DE SOTO forwardly placed for three quarters, had little left for the drive. MYLEKA settled off the pace, lacked a winning response. LONELY NIGHT SKY tired in the drive. JUMP JUMP failed to rally. SAFE TREASURE was always outrun. HEY PODZ stopped after a half.
