TEE CHELSEA dueled from the outside early, remained engaged through the turn, battled through the drive with the winner but was outfinished. FLOWING TIGRESS forced the early pace from the outside, made a bid entering the drive and was gaining late. SKY BLUE DAY chased the early pace from the inside, made a bid and finished well but too late. RUFF N WITTY went evenly. RAJA'S RULE dueled from the inside and tired. MAJESTIC BIMINI was never close. CACTUS KISS was no threat.
