BABY BWANA dueled from the outside for the early lead, gained a clear margin up the backstretch, was engaged entering the second turn, dueled through the second turn, shook loose at the eighth pole and was clear late. UBETA HOPE chased the early pace from the outside, inched close entering the second turn, dueled through the second turn, held a forward position for the drive but could not match strides. EL'S PROMISE chased the early pace from the outside, remained forward for the drive but could not keep pace. ECHOHAWK unhurried early, advanced inside entering the second turn, responded but was too late. BENDING AIR was no real threat. MAJOR CASE could only improve position. KELA'S CAJUN forced the early pace and tired. RAMBO DAY was no threat. PLEASURE'S LAD was never close. BRYANT'S MOMENT had a steady fade. WAR CONNECTION was never close.
