WINNING COMMENT crossed to the inside going to the first turn, set the pace down the backstretch, responded when collared by BELLA NOCHE, was overtaken by that one nearing mid stretch and then fought back to prevail. BELLA NOCHE eased to the inside early, moved up midway down the backstretch to stalk WINNING COMMENT, got clear in mid stretch, then was out kicked. LAKESHORE ROU devoid speed, rallied wide and was along for the show. DR. BREEZE IT allowed to settle, rallied outside and had no final kick. ZOY back early, was steered to the outside after reaching the backstretch, then remained outside while improving position. TINYBANKER close up early, faded. JACY MY GIRL was outrun. MAGNOLIA LEGEND raced wide. SHAWKLIT BELIEF was no real threat. PEACHEZ'N'KREME wide early, was not a factor. CAT'S KISSIN forwardly placed for six furlongs, gave way. KATRINA'S COCO dropped back.
