FAST KYLIE stalked DIFFERENT COLORS down the backstretch, bid outside that one around the turn, got clear and then held on. DUE A RUNNER allowed to settle, eased to the inside before the turn, remained inside while advancing around the turn, moved out in upper stretch and then was too late. DIFFERENT COLORS clear early, was collared around the turn, got headed and then weakened. BREEZE TOWN devoid speed, showed late interest. DESERT JUSTICE was outrun. LOSTTOWN was no real threat. GO MISS BAG showed little. CE CE'S TIME close up while three wide, faltered. WATCH MY TEMPER saved ground too no avail. MONEY INDA POCKET always back, broke down nearing the wire.
