ART SHIFT up close early from the outside, inched closer entering the turn, responded when sat down for the drive, dueled with KRISTINAS DAY WALK

and outnodded that one late. KRISTINAS DAY WALK stalked the early going from the outside, advanced entering the turn, responded to duel with the winner through the drive but was outnodded. KENZIE'S HEAT well placed from the inside, remained forward for the drive, responded but could only gain the show. P B RED LIGHT dueled from the outside early, remained engaged through the turn, held a forward position for the drive but had nothing left. SILVER PLANET could only improve position. SIMPLY HEATH went evenly. COMMANDER KAPP dueled from the inside and tired. TOUGH POPPA went evenly. NIKKI'S PATH was no factor. MAYBE LOCO was no threat. DANZIG'S FAULT showed little. LUKUS BOY had little interest. ADELIGHTTTOBAWHODAT was never close. ANOTHER RULER forced the early pace from the inside, fell in the stretch and was euthanized.
