PETITE REAPER set the pace from the start, drew off in upper stretch then was kept to task in late stretch while leading throughout. DOWNSHIFT DANE was chasing the early pace and taken back heading into the turn, made a bid in upper stretch but came up empty in the end. LUCKOFTHEIRISH chased the pace while three wide into the turn, made a bid in upper stretch then weakened in the drive. BIMBO COLLECT was inside and saving ground on the turn but was no threat in the stretch. CHELSEY'S STREAM was inside on the turn then failed to menace. PERUVIAN PRINCESS broke out at the start then was

settled, raced three wide on the turn and failed to menace. DIXIELAND PRINCESS was unhurried early and no factor. TENSAS GINNY LEE raced three wide on the turn and faltered. MY TURN TO BID was no factor. SWINGING KYLIE raced three wide on the turn and was no threat. CORWYNSIDEA was outrun and showed little.
