REDHOTRUSH was well placed while racing two wide then assumed command just past the half mile marker, was well handled then sat into a long drive in the stretch and proved best in the end. HANNAS AGENDA was inside and settle on the run down the backstretch, was forced to steadied sharply at the half mile and avoid the injured rival then moved up the inside on the far turn, saved ground in upper stretch making a bid and was gaining ground to finished well. ONE'S IMAGE broke slowly from the gate then was settled, started a run heading into the far turn while four wide, made a strong bid in upper stretch but flattened out in the drive. H AND F'S PROSPECT was settled in the early going then rallied three wide on the far turn making a bid to mid stretch but came up empty in late stretch. BUCK'S REVENGE was unhurried early and kept to the inside on the backstretch, saved ground on the far turn then failed to menace in the stretch. JOLLY ROCKET was unhurried early and failed to menace throughout. TIME TO REIGN was void of early speed and no threat. LEAVING TULSA was unhurried early and no factor. AFTERNOON DEPUTY chased the early pace while racing two wide on the backstretch, made a bid on the far turn then faltered in the stretch. PEACHIE KING was allowed to settle then made a three wide middle move on the backstretch to the far turn and gave way. CAJUN TRIBUTE set the early pace then stumbled badly at the half mile pole and was pulled up then vanned off. A stewards inquiry was held

concerning the incident on the backstretch. After reviewing the films, no action was taken.
