### Footnotes

STRIKE TEN broke out and bumped hard at the start then was settled for the run down the backstretch, started a picking up rivals quickly on the far turn while four wide and swept to the front in upper stretch, drew off in late stretch and was ridden out in the end. HARTCANDY was settled then moved up to be four wide and vied for the lead heading into the far turn, responded when the winner swept by at the top of the stretch and dug in gamely but was no match in late stretch while being second best. GONE LA. vied for the lead while three wide on the backstretch, was in a long sustained drive then weakened in the stretch. JUST WHATEVER was allowed to settle on the backstretch, raced two wide and split rivals in upper stretch but failed to menace in the stretch. BURN RATE was bumped hard at the start then was settled and made a mild rally while three wide on the far turn. CERTIFIEDNBONIFIED vied for the lead while inside, was used up then faltered in the stretch. PLEASANT CHOICE vied for the lead while two wide, was used up and gave way in the stretch drive. CAT LAW broke out then was bumped hard soon after the start, was unhurried early and was no factor. MR. MICHAEL J was unhurried early while inside then stopped in the stretch.
