MENASCOTT dueled for the lead while inside, was in a long drive then drew off in late stretch. BE A PRO dueled for the lead while two wide, was in a long drive and gamely dug in then tired but was still second best. TOP STAR VENTURE was allowed to settle in the early going, rallied five wide in upper stretch and was gaining ground in late stretch but was too late. R U'S GOLDEN LADY chased the pace while inside, made a bid on the turn then weakened in the drive. CAROLYNS KITTEN was unhurried early then made a mild gain in the stretch while inside but was no menace. JILLIAN'S GETAWAY chased the pace while racing two wide, was used up then faltered in the stretch. MY INCA PRINCESS was inside on the turn then failed to menace. SWEET EUGEENA raced four wide into the turn, was used and gave way. RAINDROPSAFALLING raced three wide into the turn, was hard used then faltered in the stretch drive. GIMMEALIFE trailed throughout.
