### Footnotes

SOCIALLYCHALLENGED dueled from the inside for the early lead, gained a clear margin entering the turn, was engaged by PIRATE ISLAND from the outside entering the drive, shook free from that one and was clear late while under steady urging. PIRATE ISLAND up close early from the outside, inched closer entering the turn, responded but could not match strides. COOPER JAMES forced the early pace from the inside, advanced entering the turn, responded to pressure and finished well. RYLAND T pressed the early pace from the inside, remained forward for the drive but could not keep pace. E Z VIEW could only improve position. ICEY'SFINALE was squeezed back early and could only pass tired ones. DIABLO ACT was no factor. GENE'S EXPRESS dueled from the outside and tired. ROY LAKE had a steady fade.
