HAWAIIAN CHOICE was unhurried early then rallied four wide in the stretch, was in a strong drive and got up in the final strides. CANON MAN chased the pace while inside, rallied two wide in the stretch, was gaining ground and put a head in front in late stretch but was outfinished in the end. NUN LIKE ME dueled for the lead while two wide, was in a long drive and gained a lead in mid stretch but failed to sustain that bid in the end. PROUD JEFE was allowed to settled then rallied in upper stretch, made a run ground in late stretch but was too late. TYME FOR WILLARD dueled for the lead while inside, was in a long drive and tired in late stretch. TIDE RISING was unhurried early then raced on the inside in the stretch and was no factor. SEATTLE SNIPER was unhurried early then raced three wide on the turn and failed to menace in the stretch. CASEY'S ON CALL raced three wide on the turn and stopped.
